As reported in the special newsletter in November 2018, the Trustee has chosen Sunsuper as its preferred successor fund and we are currently working toward transferring the Fund's assets and member's benefits to Sunsuper on 29 April 2019.

Our due diligence of Sunsuper is expected to be completed by the end of March. Members will receive a Significant Event Notice from CBH Super advising all the details of the transfer and a Transfer Guide from Sunsuper which provides a summary of the features of the Sunsuper product each member will be transferred to.
